



Introduction

We recently introduced a new way to track PUE time between CalPEATS and CalCATS with the release of the CalCATS Report 5 Ag Daily form. Counties can now track all PRAMR time and count items through a combination of Report 5 and (optionally) time entry in CalPEATS. With the initial release, we noticed two gaps in the interaction between CalCATS and CalPEATS for PUE time:

1. Time entered in CalPEATS on Field Worker Safety Inspections was not reported in CalCATS; and
2. Time entered directly on Enforcement Responses in CalPEATS was not reported in CalCATS and was not transferred to the PRAMR report in CalPEATS.

CalCATS Version v.2.0.2.0 addresses these gaps with two additions to the Report 5 form.

Tracking Field Worker Safety Inspection Time

If you do not use CalPEATS time tracking, you will find a new row on Report 5 where you can enter time spent on Field Worker Safety Inspections. This time is tracked and reported on your timesheet but is not transmitted to CalPEATS for PRAMR reporting.

If you enter Inspection time into CalPEATS, any time you enter on 103 Inspections will be reported on Report 5 in CalCATS on the new Field Worker Safety Inspection row.

Additional Background on Enforcement Response Time

If you do not enter time into CalPEATS and instead track all PUE time directly in CalCATS, you can ignore this section.

If your county has elected to enter time on Inspections, Investigations, Enforcement Responses,



and Training & Outreach into CalPEATS, you will see that for Enforcement Responses there are four places where you can enter time:

1. On a Compliance Action
2. On an Enforcement Action (NOPA)
3. On a Referral Action
4. On the Enforcement Response that contains the three items above.

The PRAMR Report, in sections VIII – Compliance Actions and IX – Enforcement Actions, provides space to report time reported on Compliance Actions, Enforcement Actions, and Referral Actions. Some counties have stated that ALL Enforcement Response time entry should be specific to the Response Action, and if you fall into that category and do not use the Enforcement Response time entry widget, then you can ignore this section. If, however, you do track other general Enforcement Response activity for a specific enforcement on the Enforcement Response record, then we have updated CalCATS to track and report this time as Other Licensed Enforcement Hours (PRAMR Section XIV.B).

Tracking Non-Specific Enforcement Response Time

The Report 5 form in CalCATS has been updated for counties that enter time in CalPEATS to include an additional subset of Other Licensed Enforcement Hours titled Enforcement Responses. Time entered on Enforcement Responses in CalPEATS (directly on the Enforcement Response, not on any specific Response Action) will appear here and will be added to Other Licensed Enforcement Hours on the PRAMR report in CalPEATS.
